Power of Attorney and Declaration of Release from Liability

I am a member of the B.A. GC Bad Lippspringe e.V., successor to the "Gesellschaft bürgerlichen Rechts der zivilen Mitbenutzer außerhalb des Gefolges der britischen Streitkräfte" (Civilian Joint Users Association outside the British Armed Forces) and a joint user of the British Armed Forces golf course in Bad Lippspringe under the terms of the Joint Use Agreement of 22.11.2001.

The golf course is located on the territory of the Senne military training area. The Senne military training area is owned by the Federal Real Estate Agency (Bundesanstalt für Immobilienaufgaben); it has been ceded to the British armed forces for military use in accordance with Article 48 of the Supplementary Agreement to the NATO Status of Forces.

I am aware of the contents of the Joint Use Agreement of 22.11.2001 concluded between the Federal Republic of Germany (since 01.01.2005 "Bundesanstalt für Immobilienaufgaben") and the civil law partnership of civilian joint users outside the retinue of the British armed forces. In particular, I am aware of the wording of \$ 2(1), (2) and (3).

With this in mind, I expressly declare that my shared use of the British Forces golf course in Bad Lippspringe is at my own risk. I release the Bundesanstalt für Immobilienaufgaben and the British Armed Forces from any liability. I expressly waive all claims against the Bundesanstalt für Immobilienaufgaben and the British Armed Forces which could arise from the shared use. This includes, in particular, damage to property and personal injury resulting from accidents or injuries, including those resulting in death. I release the Bundesanstalt für Immobilienaufgaben and the British Armed Forces from all compensation for damages due to claims by third parties that could arise from the shared use.

I hereby expressly authorise and instruct the respective registered association representative and his deputy to represent me in all matters relating to the joint use of the golf course on the Senne military training area, to make legally effective declarations on my behalf and, in particular, to sign amendments and supplements to the joint use agreement of 22.11.2001 on my behalf in a legally effective manner until revoked by me in writing.

Information on the processing of your personal data at the British Army Golf Club Sennelager

With the following presentation we would like to inform you comprehensively about the processing of your personal data in our golf club. Your data will be processed by us, but also by third parties, such as the German Golf Association (DGV).

1. Processing of your data by the DGV

Data concerning you will be passed on to the DGV, Kreuzberger Ring 64, 65205 Wiesbaden, in particular for the purpose of ordering your DGV membership card and for the handling of betting games (compilation of starting lists, etc.). In detail, this involves the following data for use for the purposes also described below:

- a) for the issuance of the DGV Identity Card the membership number, surname, first name, title, function in the club, playing rights and handicap of the golfer as well as the country code, date of birth, age category, gender, year of issuance of the card, date of validity of the card, date of order of the card as well as the date of the handicap,
- b) for the illustration of a regionality indicator on the DGV Card, the distance between a residential address of the Cardholder and the clubhouse of the DGV Member issuing the DGV Card,
- c) for the purpose of assigning a unique player identification number, the surname, first name, sex, date of birth, postcode and club number,
- d) for the analysis of the catchment areas of golf courses, the country codes and the postcodes of the places of residence,
- e) for forwarding to the home club, for determining rankings and for statistical evaluations by the DGV and the LGV, the betting game results of the golfers,
- f) for the presentation of betting results on www.golf.de name, first name, title, gender, name of the home club, betting results and handicap data (unless the publication has been objected to by the golfer concerned),
- g) for the creation of entry and start lists of golf tournaments for publication on www.golf.de DGV number, name of home club, membership number, player identification number, surname, first name, title, handicap, tournament, start time, player group and tee time. Access to the entry list is limited to the persons registered for the tournament; access to start lists is limited to the persons of a player group,
- h) for the purpose of displaying entry, start and handicap lists as well as betting game results, passing on the data mentioned in letters (e. and f.) above to the operator of the internet portal www.mygolf.de (unless the publication has been objected to by the golfer concerned). Access to handicap lists is restricted to persons with an identical home club; access to entry lists is restricted to persons registered for the tournament; access to start lists is restricted to persons in a group of players,
- i) for the purpose of passing on guest player queries from foreign golf clubs which belong to an EGA member (only within the EU or in countries with an appropriate level of data protection recognised by the EU) first name, surname, title, gender, date of birth, name of the home club, DGV number, membership number, master handicap (incl. date) and the player identification number. In the case of guest player queries from DGV members, the age category, the function in the club, any existing handicap ban, the playing rights in the club and the expiry date of the DGV card will also be passed on,
- for publication on the Internet at www.golf.de/dgv, the first names, names, titles, functions and e-mail addresses of the functionaries. If the DGV member

transfers personal data to the DGV intranet that goes beyond the circle of functionaries of the DGV member, he/she must ensure that written consent has been obtained from the person concernedt.

You can object to the use of the data mentioned under letters f. and h. at any time. Your aforementioned data will be deleted by the DGV no later than one year after you leave the golf club, unless you join another golf club that is also a regular member with play in the DGV.

The provision of personal data to the DGV is based on the Data Protection Policy of the British Army Golf Club Sennelager and the Admission and Membership Guidelines of the DGV, the validity of which you have accepted by joining the British Army Golf Club Sennelager (hereinafter only Golf Club). This data processing is carried out for the purpose of fulfilling the membership relationship in the golf club and is therefore based on Art. 6 Para. 1 lit. b) EU Data Protection Regulation (DSGVO).

2. Processing of your data by the Golf Club

In addition, the Golf Club processes the following personal data:

- a) to reserve/block starting times Name, first name, gender, e-mail and telephone number.
- b) for the publication of tee times via a screen in the secretary's office surname, first name, sex and EGA handicap,
- c) to carry out the procedure for admission to the golf club, name, first name, sex, date of birth, address, e-mail address, telephone number, bank details,
- d) for the administration of your membership in the golf club surname, first name, sex, date of birth, address, e-mail address, telephone number, bank details, household and family affiliation in the case of allocation to the family contribution
- e) for the purpose of collecting membership fees and additional fees (loose rent, starting fees, association fees, etc.), including dunning and collection, as well as for processing payment transactions via the (online) banking software of the golf club, surname, first name, gender, address, bank details,
- f) for the dispatch of newsletters, club information, invitations to members' meetings, birthday e-mails and comparable information, surname, first name, sex, e-mail address; the newsletter is dispatched via the golf club.
- g) for access to changing rooms, caddie boxes, ball machine etc. by means of DGV ID card/service card surname, first name, gender, membership number, telephone number
- for publication in the form of a live result service (e.g. in the clubhouse via a screen) surname, first name, gender, EGA handicap, match result (so-called live scoring),
- for the organisation of the youth training (address, notification, coordination of appointments) name, first name, gender, e-mail address and telephone number of the youth members,
- j) for processing incoming and outgoing mail via EDP as well as fax and e-mail name, first name, gender, address, e-mail address,
- to improve the quality of service, to compile statistics and planning (liquidity planning, cost-benefit calculation, etc.) as well as for controlling purposes, the number of rounds played by you p.a. as well as the annual turnover achieved (ball machine, etc.),
- to improve the quality of service for surveys, name, first name, gender, e-mail address,

- m) for the purpose of issuing a membership directory to all Club members as well as for publication in the protected member area on the Club homepage, name, first name, gender, address, e-mail address,
- n) for the purpose of publishing the playing schedules in the clubhouse name, first name, gender, EGA handicap,
- o) for the purpose of organising group/league team play, forwarding of surname, first name, e-mail address to the captains of the teams and groups
- p) for the purpose of organising the round-robin catering at the half-way house name, first name, gender, gastronomic wishes,
- q) for the naming and publication of the club champions at the club house surname, first name, gender of the club champions,
- r) to control the administration, in particular to check proper bookkeeping the membership data,
- s) for the prevention of criminal offences and the collection of evidence in the event of vandalism, burglary or other criminal offences, moving image data recorded by video surveillance equipment on the Club premises.

The data processing described above (letters a. to j. inclusive) is carried out for the purpose of fulfilling your membership relationship in the golf club and is based in this respect on Art. 6 Para. 1 lit. b) DSGVO.

With the processing of letters k. to s. inclusive, the golf club pursues the intention of offering its members the greatest possible service in practising golf and promoting the common interest of its members in practising golf in the golf club. The legal basis for this data processing is Art. 6 para. 1 lit. f) DSGVO.

Only the employees and officers of the golf club are involved in processing your personal data at the golf club. If third parties also process personal data, this is done on behalf of and in accordance with the specifications of the golf club within the framework of an agreement on data processing on behalf (Art. 28 DSGVO).

Your processed personal data will be deleted by us as soon as your personal data is no longer required for the described processing purposes (e.g. when you leave the golf club) and there are no further statutory retention obligations - for example for reasons of tax law.

3. Your Rights

You can request information from us at any time about the personal data concerning you, in particular about the information listed in detail in Art. 15 DSGVO.

You have the right to request correction and, if necessary, completion of incorrect/incomplete data concerning you (Art. 16 DSGVO). In addition, you may request the immediate deletion of your personal data if one of the reasons listed in detail in Article 17 of the GDPR applies, e.g. if the data is no longer required for the purposes pursued.

You also have the right to request the restriction of processing if one of the conditions listed in Art. 18 DSGVO applies, e.g. for the duration of the review by us if you have objected to the processing of your data.

In addition, you can request a transfer of your data to another ordinary member with playing operations in the DGV.

You may object to the processing of your personal data as described in section 1. letters f. and h. and section 2. letters k. to r. inclusive at any time. In this case, your personal data will no longer be processed by us unless we can prove that there are compelling reasons for the processing which are worthy of protection and which override your interests, rights and freedoms, or the processing serves to assert, exercise or defend legal claims (Art. 21 DSGVO).

If you believe that the processing of your personal data violates applicable data protection law, please contact us or our data protection officer (contact details below). If we are unable to resolve your concerns, you can contact the supervisory authority responsible for the golf club:
